PAYMENT OF DEPOSITORS OF INVESTRUST BANK PLC (IN POSSESSION)

Notice is hereby given to depositors of Investrust Bank Plc (In Possession) that an initial payment of up to K500,000.00 per deposit account will be made from 26th April to 10th May, 2024.

Further, due to logistical arrangements, payments for depositors in Lumwana, Luangwa, and Chililabombwe will commence on 27 April 2024.


